





An Update On the Situation of Human Rights Defenders in Saudi Arabia

Saudi Arabia Briefing Paper – Universal Periodic Review – October 2018

Intimidation and Reprisals for Accessing International and Regional Mechanisms

• HRD Issa al-Nukheifi was targeted for cooperating with the mandate of the Special Rapporteur on extreme poverty and human rights ahead of his January 2017 to the country. The 2018 Secretary General's reprisals report also highlighted the case of Salim Abdullah Hussain Abu Abdullah, who was the subject of an opinion by the Working Group on Arbitrary Detention in June 2017 and he has since been repeatedly placed in solitary confinement and been denied regular contact with his family.¹

Crackdown against women human rights defenders

- Dozens of WHRDs who have been active in the campaign to end the driving ban and the guardianship system have been arrested and detained in 2018. Noha Al Balawi and Maria Naji were detained in January 2018, while Loujain al-Hathoul, Dr. Eman Al-Nafjan and Aziza Al Youssef in May 2018 and continue to be detained. Dr. Aisha al-Mana, Madeha al-Ajroush, Hessa al-Sheikh and Walaa Al Shubbar were also arrested in May 2018 but have been released. Dr. Hatoon al-Fassi as well as Ibrahim al-Modeimigh, and members of ACPRA Mohammed al-Bajadi are also detained.² Many of the charges are state security related but stem from activism promoting women's rights. Official and semi-official media outlets embarked on a defamation campaign against the detained WHRDs calling them "traitors" and "agents of embassies". ³
- On 30 July 2018, Saudi officials arrested prominent WHRDs Samar Badawi and Naseema Alsada. They are being held in solitary confinement and have been denied access to their lawyers and contact with their families.⁴
- On 21 August 2018, the kingdom's public prosecutor recommended the SCC give six human rights defenders, including Israa al-Ghomgham the death sentence. If the court accepts the recommendation and the king upholds the verdict, al-Ghomgham would become the first woman executed for human rights activism and advocacy.⁵
